**2020 Delegate Selection Plan**

**DELEGATE KIT**

Planning is underway for the 2020 Democratic National Convention to be held in Milwaukee, Wisconsin, Monday, July 13 – Thursday, July 16, 2020. We hope that many of you will consider serving as a delegate to the convention and we want to provide information so that you can prepare for this exciting opportunity.

**What to expect as a Delegate to the National Convention:**

- You will be responsible for transportation, lodging, meals and entertainment.
- The DNC recommendation is to fly to Chicago; transportation will be provided to the hotel by the DNC.
- Delegates **MUST** arrive by 6:00 pm on Sunday, July 12, 2020
- Be prepared to pay for your meals, though there are many Delegate Events you will be invited to attend that include meals and refreshments. You will receive further details about such events prior to and during the convention week.

**The Connecticut Democratic Party will provide:**

- Delegation activities highlighting members of our delegation, elected officials or surrogates
- Facilitate credential distribution (ensure that Delegates are present and voting during the proceedings)
- Provide information about DNCC activities (tickets and special access is not guaranteed)

**Be aware the days are long:**

- 7:00AM – 4:00PM DNC Constituency Caucus meetings and convention proceedings
- 4:00PM – 9:00PM Delegate entertainment/activities

**Please note:**

- Our hotel will be located **over an hour** from the convention site.

Transportation to the convention site will be provided by bus going in twice a day and returning after the convention has ending each evening.

## **FAQ**

**What is a Delegate to the National Convention?**

A Delegate represents the Democrats from their Congressional District at the National Convention to be held in July of 2020 in Milwaukee, WI and their vote will help decide who will be our Democratic Nominee.

**Why would I want to be a Delegate?**

Not only would you be one of a couple thousand people with the honor of formally selecting our party's nominee, you get a front row seat to history in the making. Hear amazing speeches by people you probably have only seen on TV, attend political caucus meetings, and enjoy yourself at the numerous parties and dinners over 4 nights. It's been called *Disney Land* for political geeks...

**How do I become a District-Level Delegate?**

Most Delegates are elected at a Congressional District Caucus (a meeting of any interested Democrats) held by each campaign that won Delegates in the primary. Connecticut has 5 districts, and Presidential Campaigns that win Delegates split them proportionally. Each district only has 8 Delegate positions, and they are split equally between men and women. (There are also Automatic Delegates like our Senators, and a small group of Delegates appointed by the State Party.)

**Can I apply to be both a District-Level Delegate and an At-Large Delegate at the same time?**

Yes - but you should only apply once for each position.

If you want to be a District-Level Delegate, you have to win your seat at one of these caucuses. How do you do that? The best way is to volunteer for that campaign and impress them with your dedication. The campaigns can endorse a slate if they choose to – or just leave it up to the caucus to vote. If you want to win bring your Democratic friends, family and neighbors along and ask them to support you! You can also ask the other Democrats who are there for their votes!

### **How do I become an At-Large Delegate?**

The At-Large Delegates (14 Delegates, 5 Alternates) are elected by the Democratic State Central Committee on June 10, 2020. You need to send your completed application to [conventions@ctdems.org](mailto:conventions@ctdems.org) by May 28, 2020 at 5 pm.

### **A few things to keep in mind...**

- You must be a registered Democrat residing in Connecticut.
- District and At-Large Delegates sign a pledge to support the Presidential Candidate they are representing.
- The State Party is making every effort to have a Delegation that reflects Connecticut, so we are reaching out all over the state to encourage people from every community to run. But remember most Delegates are elected, and we don't control the outcome.
- This is an expensive trip. We'll have firm numbers later but assume it will cost you at least \$2,000. If you win, and don't have that much cash to spend you can consider asking friends and family to donate – or even set up a go fund me page! If you are involved in any Community Groups, they might be willing to lend a hand. If there are any other sources of support the State Party will do their best to let you know.
- For District-Level Delegates, only 8 people from your entire Congressional District will be elected, and in the past at times more than 50 people have applied.
- Completed District-Level Delegate applications are due by 5 pm on May 4, 2020 at 5 pm. These applications name which Presidential Campaign you wish to represent.  
**Each Campaign has the chance to approve their applicants** – so you may want to volunteer and connect with campaign staff.
- The district caucuses are on May 27, 2020. Make sure you and all your supporters show up on time! The caucuses for different Presidential Campaigns are all at the same time so you will be able to attend only one of them.

*Here is the summary of the Delegate selection plan, which has been approved by the DNC.*

### **Summary of Plan**

#### **A. Selection of Delegates and Alternates**

Connecticut will use a proportional representation system based on the results of the Presidential Primary apportioning its delegates to the 2020 Democratic National Convention.

The “first determining step” of Connecticut’s delegate selection process will occur on April 28, 2020, with a Primary.

Delegates and alternates will be selected as summarized on the following chart:

\* Automatic Party Leader and Elected Official (PLEO) delegates includes the following categories, if applicable, who legally reside in the state: the Democratic National Committee Members, the Democratic President, the Democratic Vice President, all Democratic members of the U.S. House of Representatives and the U.S. Senate, the Democratic Governor, and any other Distinguished Party Leader as specified in Rule 9.A. of the 2020 Delegate Selection Rules. The exact number of Automatic PLEO Delegates is subject to change due to possible deaths, resignations, elections or special elections.

\*\* Pledged Party Leader and Elected Official (PLEO) alternates are selected with the At-Large alternates.

## **B. Selection of Standing Committee Members (For the Credentials, Platform and Rules Committees)**

Standing committee members will be selected by the state's National Convention delegates as summarized below:

## **C. Selection of Temporary Standing Committee Members (For the Credentials, Platform and Rules Committees)**

## **D. Selection of Delegation Chair and Convention Pages**

The Delegation Chair will be selected by the National Convention Delegates on June 17, 2020.

Two (2) Convention Pages will be selected by the State Democratic Chair on June 17, 2020.

## **E. Selection of Presidential Electors**

Seven (7) Presidential Electors will be nominated at the state convention on May 9, 2020.

## **F. Presidential Candidate Filing Deadline**

Presidential candidates must certify the name of their authorized representative(s) to the State Democratic Chair by March 7, 2020.

In accordance with Connecticut State Law, nationally recognized candidates for the Democratic nomination for President will be placed on the presidential preference primary ballot by Secretary of the State on February 14, 2020.

Deadline for enrolled party members to transfer enrollment from one party to the other for the presidential primary.

2/14/2020

Presidential candidate petition forms available for ballot access.

3/06/2020

DNC Secretary officially confirms the names of the Automatic delegates to State Party.  
Deadline for presidential candidate petition forms due to local Registrar of voters.

3/07/2020

Each presidential candidate shall certify in writing the name of their authorized representative to the State Democratic Chair.

3/10/2020

Deadline for Registrar of Voters to forward signed petition forms to the Secretary of the State.\

3/13/2020

Deadline for Secretary of the State to tabulate qualifying signatures for presidential candidate petition forms.

4/23/2020

Registration Deadline for new voters and unaffiliated voters to register to vote as a Democrat in the presidential primary.

4/28/2020      Presidential Primary

4/30/2020

Deadline for Democratic State Central Rules Committee to draw up and the State Central Committee to approve detailed guidelines for the conduct of the delegate selection caucuses.

5/1/2020

Deadline for Presidential Electors to submit their application for nomination to [convention@ctdems.org](mailto:convention@ctdems.org) or 30 Arbor Street, Ste. 106A, Hartford, CT 06106.

5/04/2020

Deadline for an individual to file a statement of candidacy for district-level delegate. Will be made available at ctdems.org and CT Dems Office, 30 Arbor Street, Ste. 106A, Hartford, CT.

5/09/2020

State Convention where Presidential Electors will be nominated by a majority vote of the delegates present and voting.

5/11/2020

State Party provides list of district-level delegate candidates to the respective Presidential candidates.

5/13/2020

Presidential candidates provide list of approved district-level delegate candidates to the State Party.

Deadline for State Chair to submit certified list of Presidential Electors to the Connecticut Secretary of the State.

05/27/2020

Congressional District Caucuses to select district-level delegate candidates.

5/28/2020

Deadline for PLEO and At-Large delegate candidates to file statement of candidacy to the state party.

5/31/2020

State Party sends list of PLEO delegate and At-Large delegate and alternate candidates to respective Presidential candidates.

6/03/2020

Presidential candidates provide list of approved PLEO delegate candidates to the State Party.

6/06/2020

Deadline for State Party Chair certify district-level delegates to the Secretary of the DNC.

6/10/2020

State Party Committee meets at 30 Arbor Street, Ste. 106A, Hartford.

Selection of PLEO delegates.

Presidential candidates provide list of approved At-Large delegate and alternate candidates to State Party.

Selection of At-Large delegates and alternates.

06/15/2020

Presidential candidates provide list of approved delegates to be members of standing committees.

06/17/2020

National Convention delegation meeting. Delegates select National Convention Standing Committee Members and Delegation Chair. State Chair names convention pages.

06/20/2020

State Democratic Chair certifies PLEO and AT-Large Delegates, the standing committee members, Delegation Chair and Connecticut's Convention Pages to the Secretary of the DNC.
